 - Scaled drawing(s) that are readable on letter size paper for small projects and 11" x 17" for large
 - List of plantings (species, size)

- *FENCE INSTALLATION OR CHANGE**
 - Site plan showing proposed fence location in relation to property lines and front elevation of home
 - Fence material, color, height, and design specifications (see ACC requirements and fencing plan in guidelines)
 - Invisible Pet Fence: Site plan showing proposed location. Must be setback from unfenced/open property lines.
- *ARCHITECTURAL** (i.e., Remodel, Alteration, Roofing, Patio, Patio Cover, Automatic Shades, Pool, Hot Tub, etc.)
 - Scaled drawing(s) that are readable on letter size paper for small projects and 11" x 17" for larger
 - Examples of all materials to be utilized. Photos are usually accepted, but actual samples may be requested.
- *EXTERIOR PAINT**
 - Same colors:** Pictures of existing and if available, color description/identification to be applied.
 - Different colors:** Pictures of existing and description of new paint including color description/identification/color swatch for each area. I.e., fascia, siding, garage door, front door, trim, accents, etc. Photos are usually accepted, but actual samples may be requested.
- *OTHER** (i.e., Solar, Flag Poles, Trash Receptacle Screening, etc.):
 - Specifications including design, materials, location, aesthetics, etc. See ACC Guidelines and CC&Rs for details.
